#### Declaration

In the light of mutual understanding and cooperation all Teacher Trade Unions in Cyprus agree on a rotational system for representation to the ETUCE Committee in the following way:

- The rotation on the country seat is between the Greek Cypriot and Turkish Cypriot Communities as defined in the 1960 Cyprus Republic Constitution.
